Review and comment on the draft Office of National Marine Sanctuaries 2013
National Condition Report by the CINMS Research Activities Panel, Meeting of April 2, 2013²

The Research Activities Panel (RAP), a working group of the Channel Islands National Marine Sanctuary (CINMS) Advisory Council, held an annual meeting on April 2, 2013. The RAP appreciates the efforts that CINMS has made in the face of declining fiscal resources to continue to collaborate with local researchers and to support research activities through vessel time on the R/V *Shearwater* and R/V *Sharkcat*, which are important assets to the research community.

As part of the meeting agenda, we reviewed the draft ONMS 2013 National Condition Report. This document is an overview constructed from the results of 14 Site Condition Reports completed for all units of the National Marine Sanctuary System (NMSS) over the last 5 years. As stated, "it is an assessment of the pressures on and state of resources across the NMSS, and offers a summary of actions, both taken and planned in response to those findings."

In September of 2008 the RAP commented on the CINMS Condition Report, expressing a number of concerns about the relative roles of opinion and monitoring-derived data in the development of that report. Among the issues raised was our concern that the summary answers to the Condition Report questions were derived from widely differing information bases, ranging from unsupported expert opinion to thorough monitoring data. In addition, these diverse sources were synthesized into rating scores through similarly diverse and untestable evaluation processes. While the quality of the support for a particular rating was highly variable, all ratings appeared to be granted equal weight in assessing the condition of the CINMS. We expressed our opinion at that time that if all questions and subsequent ratings were of equal value in assessing condition, then those areas whose ratings were based on poor data should be the targets of increased monitoring and targeted research. Additionally, if conditions in a particular area appeared to be deteriorating according to expert opinion, this would also suggest an area that required investigation through monitoring and research. Many recent events suggest that actual management actions should be based on reliable information, or we risk disastrous and misapplied expenditures with little return.

In the draft National Condition Report, concerns about data and evaluation quality - such as those identified in our previous review of the CINMS Condition Report - are not expressed. Previously identified problems are exacerbated here because comparisons are now made across the Sanctuary Condition Reports, with no knowledge of the underlying variability of information that led to site-specific ratings. Monitoring programs are described in some detail in several places in the document, but this is juxtaposed with admissions that very little monitoring or targeted research is being carried out broadly within the NMSS. There is no specific information concerning which sites are conducting targeted monitoring and which are not. The need for monitoring is stressed, but there is no way forward suggested except a vague charge to "work with other agencies".

If no indicators of the quality of information are to be made available in this document, there should at least be a disclaimer that these results should not be used as the basis for management action. Rather, these ratings (and the quality of information leading to the ratings) should be used as a guide toward the most pressing needs for accurate information.

Our greatest concern is that such reports, both in local and nationally summarized forms, will be used as a substitute for reliable, actionable information. Although stated many times in the past, it remains true: **Expert opinion cannot be used as a cheap alternative to monitoring**. Equally, if these ratings are produced solely in order to fulfill some reporting requirement, then they should carry cautions about their limitations and the dangers of their use in policy and management decisions.

Before we take action on problems, we need to know what the problems are. The NMS should take the lead in documenting the actual state of the Sanctuaries though a funded effort in monitoring and targeted research.
